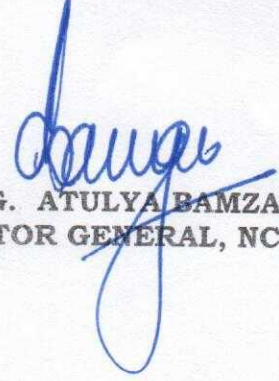

NOTIFICATION

No.F.9(88)/AO-NCC/RR/Ex-Cadre/CH/2023 :- In exercise of the powers confirmed by provision to Article 309 of the Constitution of India and in supersession of previous recruitment rule No.F.2(14)/87-S.II, dated 10.06.1987 and amended from time to time for the post in the National Cadet Corps Department, Government of National Capital Territory of Delhi, the Lt. Governor, National Capital Territory of Delhi hereby makes rules regulating the method of recruitment to the post of Multi Tasking Staff (Security) in National Cadet Corps Department, Government of National Capital Territory of Delhi, namely :-

1. **Short title and Commencement:-** (i) These rules may be called the National Cadet Corps Department, Government of National Capital Territory of Delhi, Multi Tasking Staff (Security), Recruitment Rules 2023.
(ii) They shall come into force on the date of their publication in the official Gazette.
2. **Number of Posts, its classification and Pay Level in the Pay matrix:-** The number of said posts, its classification and Level in Pay matrix attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
3. **Method of Recruitment, Age Limit, Qualification etc.:-** The method of recruitment, age limit qualifications and other matters relating to the said post shall be specified in columns 5 to 13 of the said Schedule.
4. **Disqualifications:- No Person -**
 - (a) Who has entered into or contracted a marriage with a person having a spouse living;
or
 - (b) Who having a spouse living, has entered into or contracted a marriage with any person:
shall be eligible for appointment to the said post:

Provided that the Government may, if satisfied, that such marriage is permissible under the personal law applicable to the such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. **Power to relax:-** Where the Government is of the opinion that it is necessary expedient so to do, it may be order, and for the reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
6. **Saving -**Nothing in these rules shall affect reservations, relaxations of age limit and other concessions required to be provided for the Schedule Castes, Schedules Tribes, Ex-Servicemen, Other Backward Classes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
