NOTIFICATION

No.F.9(92)/AO-NCC/Ex-Cadre/HVD/2023--:- In exercise of the powers confirmed by provision to Article 309 of the Constitution of India and in accordance with the Military Engineer Service (Civilian Motor Driver) Recruitment Rule 2008 and S.R.O. 29 dated 29.03.2022 and in supersession of all previous recruitment rules issued time to time for the post of Driver (Heavy Motor Vehicle) Ordinary Grade, Grade-II, Grade-I and Special Grade in the National Cadet Corps Department, Government of National Capital Territory of Delhi, the Lt. Governor, National Capital Territory of Delhi hereby makes rules regulating the method of recruitment to the post of Driver (Heavy Motor Vehicle) Ordinary Grade, Grade-II, Grade-I and Special Grade in National Cadet Corps Department, Government of National Capital Territory of Delhi, namely :-

1. **Short title and Commencement:-** (i) These rules may be called the National Cadet Corps Department, Government of National Capital Territory of Delhi, Driver (Heavy Motor Vehicle) Ordinary Grade, Grade-II, Grade-I and Special Grade Recruitment Rules, 2023.
(ii) They shall come into force on the date of their publication in the official Gazette.
2. **Number of Posts, its classification and Pay Level in the Pay matrix:-** The number of said posts, its classification and Level in Pay matrix attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.
3. **Method of Recruitment, Age Limit, Qualification etc.:-** The method of recruitment, age limit qualifications and other matters relating to the said post shall be specified in columns 5 to 13 of the said Schedule.
4. **Disqualifications:- No Person -**
 - (a) Who has entered into or contracted a marriage with a person having a spouse living;
or
 - (b) Who having a spouse living, has entered into or contracted a marriage with any person; shall be eligible for appointment to the said post:

Provided that the Government may, if satisfied, that such marriage is permissible under the personal law applicable to the such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. **Power to relax:-** Where the Government is of the opinion that it is necessary expedient so to do, it may be order, and for the reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
6. **Saving** -Nothing in these rules shall affect reservations, relaxations of age limit and other concessions required to be provided for the Schedule Castes, Schedules Tribes, Ex-Servicemen, Other Backward Classes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
